## Minutes of the 18th meeting of the Startup Task Force under Odisha Startup Policy-2016 held on 06.04.2021 at 03.30 PM

The 18<sup>th</sup> meeting of the Task Force, constituted under Odisha Startup Policy-2016, was held on 06<sup>th</sup> April 2021 virtually under the Chairmanship of Principal Secretary, MSME. The list of members, who were present and participated in the meeting, is given at the **Annexure-I**.

The following are the decisions taken agenda-wise:

### Item 1. Confirmation of minutes of the 17<sup>th</sup> Task Force Meeting

The minutes of the 17<sup>th</sup>meeting of the Task Force held on 03<sup>rd</sup> November 2020in the Conference hall of MSME Department, Odisha under the Chairmanship of Shri Satyabrata Sahu IAS,Principal Secretary, MSME were circulated to all members. #### Item 4. Financial Assistance to Startups

CEO, IEDO informed the Task Force that Monthly Allowance Grant has been released to 93 Startups, Product Development and Marketing/Publicity Assistance has been released to 38 Startups and Need Based Assistance has been released to 09 Startups as approved earlier by the Task Force and Startup Council.

# Item 5. Financial applications recommended by sub-committee for approval
